- Install all framing needed, new stair stringers, framing for lattice below the deck, support columns, etc.
- 3. Build new deck rails.

square posts

1x3 ballisters

2x4 top and bottom rails

- 4. Build new stairs
- 5. Install lattice below all deck framing.
- 6. Build removable screen panels, including a door, for the porch

All work shall comply with the 2015 IRC, while complying with historic requirements and following lead safe procedures.


