Good afternoon Ted, Jamie, and Doug,

You are probably aware that ATO is seeking to establish their fraternity in the former Elizabeth DeMeritt House on Garrison Avenue. The Planning Board is holding a public hearing on their preliminary application on March 11. Their plan is to retain the existing building (I am certainly pleased about that), build a 2-1/2 story addition on the right side, and create a parking lot with 30 spaces. They said they plan to have 34-40 members living there. They will need a variance for parking to be located in the wetland overlay district and several conditional uses.
