Hi Michael – based on our meeting on site, we ask that the application pitch concrete patio such that stormwater is not sheeting off patio and onto the roadway.

The small corner patch of existing grass adjacent to the asphalt entrance walkway shall be used as a infiltration area for this stormwater.

Use 8-10 inches – ¾' stone layer to infiltrate , with a layer of geotextile fabric. Top filter media should be 6-8 inches loamy sand topsoil. Plant with material that will stabilize the surface.
