Hi Michael, I hope you are well.

Tideline is in fact asking to extend its hours of operation from the originally agreed upon 10pm, to four hours later, or 2am. That is precisely what we are talking about. The food trucks are a key part of its business operation. Food trucks now close at 10pm and under the amendment they would operate much later for half of the year.

I think you have to ask yourselves whether a business that billed itself as a good neighbor to residents and used the 10pm restriction as a marketing ploy during the original site plan discussions should be allowed to do an about-face less than a year later.

The extended hours will generate additional traffic and noise, but the real problem will be damage to the Planning Board's credibility, due its lack of consistency and backbone. The townspeople signed up for one kind of business and, by allowing the amendment, you will facilitate another. By your logic, next year they can apply for yet another modification and the following year another, until the original siteplan is but an afterthought.
