Short-Term Rental – An accessory use to an owner-occupied single-family residence containing, in addition to living accommodations for the owner and the owner’s family, not more than three sleeping rooms, for the purpose of providing to the general public, for compensation, lodging, with or without breakfast, for less than thirty (30) consecutive days. A short-term rental is not considered a home occupation. A floor plan of the rental area is required with this application. Please see additional requirements below.

Short-Term Rental Requirements

The property owner shall submit an application to operate a short-term rental to the Zoning Administrator. The proposal shall be reviewed for compliance with all Building, Fire, and Life Safety Codes. (Site plan review is not required for a short-term rental.) **Please initial each below showing adherence to the requirements.**

- LM A short-term rental is permitted within the property’s zoning district.
- LM The site where the short-term rental is located is the property owner’s primary residence.
- LM The property owner or a member of the property owner’s family is on the premises overnight each night while the property is rented.
- LM Those areas of the premises open to use by lodgers remain subject to periodic safety inspections per state law.
